The ProSign2- project is a continuation of ProSign1, a project carried out between 2012 and 2012. ProSign 1 aimed to share information among Sign Language Teachers and other stakeholders regarding the CEFR (Common European Framework for Modern Languages). In this successfull project the CEFR was translated into International Sign and published on the ECML website. ProSign2 continues the search for good practices within the field of Sign Language Teaching. Among the associate partners of ProSign is the European SignTeach Consortium. Both projects can reinforce each other. In the ProSign2 workshop held in march 2017 the European Language Portfolio was intensively discussed, and a number of participants expressed their intention to start a pilot to use the ELP as a tool for students to track their development. The results of these pilots will be shared later. Besides the ELP, the workshop participants were informed about the SLPI-assessment, an assessment that adapted for Sign Language of the Netherlands. The instrument is usefull to assess advanced (B2) sign language users.
